To Whom It May concern:

It has been requested of me to make a written statement regarding the issuance of building permits for 20 Country Club Lane, Woodstock, New York doing business as Selina Woodstock Real Estate.

On 3/22/19 a permit application for interior demolitions for the lodge building, and buildings identified on the master list as building 1 & 8 were submitted to the building department.

The application was reviewed and issued on 3/25/19. Despite the claims of two neighbors, there were no violations on the property at the time of issuance.

The violations that were issued to the property were issued in July 2018. The violations consisted of operating the swimming pool without health department approval, off premise sign, and for exterior modification to site.

All prior violations have been removed. I requested the Lodge go back to the planning board to complete the site plan review process. On 4/2/2019, I submitted a referral to the planning board for modifications to site plan.

On May 1, 2019, I approved the construction application to reconstruct building 1, and renovate building 8, as well as the lodge.
